The following 2nd Grade Draftsman / Overseers who are included in the final seniority list of 2nd Grade Draftsman / Overseer published vide order 3rd cited are here by provisionally promoted as 1st Grade Draftsman / Overseer as per rule 31(a) of KS&SSR 1958 and posted to the offices noted against their name. The promotees are placed under probation for two years within a continuous service of three years from the date of joining duty as 1st Grade Draftsman / Overseer. This order can be down loaded from the official Website of PWD www.keralapwd.gov.in and circulated to the concerned incumbents and allow to relieve or join duty.

The controlling officers should relieve the promotees without waiting for substitute within 15 days of this order. If there is any change in the present status of the incumbents the controlling officers may also report the fact to this office without delay.

Since the seniority list of 2nd Grade Draftsman / Overseers who opted PWD for the period from 01/08/1985 to 31/03/1990 had been revised consequent to the judgment of Honourable High Court read 7th and GO (Rt) No. 1836/08/PWD dated: 06/11/2008. Due to the above revision 31 numbers of the incumbents who were not considered for promotion earlier have been since included in the promotion list. The date of effect of promotion of Overseers who have already promoted vide this office order 1st and 2nd read above are here by modified as per the vacancies available during the period as detailed below.

The 2nd Grade Draftsman/Overseer in the revised seniority list holding rank number 1 to 107 (Sri. Mohanan D.) provisionally promoted with effect from 26/03/2008 (82 vacancy) and rank number 108 to 153 (Smt. Sabura P.) promoted with effect from 30/06/2008 (45 vacancy) and remaining rank number 154 to 181 (Smt. Janet R.) is provisionally promoted with effect from 01/12/2008 except those who opted LSGD and not eligible for promotion in PWD as 1st Grade Draftsman / Overseer.


