As per read 3<sup>rd</sup> paper cited, Assistant Engineer, Special Buildings Section II, Kollam has forwarded the service details of Sri. Nazarudin. A, 3<sup>rd</sup> Grade Overseer to include his name in the Final Seniority List of 3<sup>rd</sup> Grade Overseer as on 31/3/1990 published vide read as 1<sup>st</sup> paper above.

On verification of relevant records it is found that his name is not included in the above seniority list and in the common seniority list of 3<sup>rd</sup> Grade Overseers. As per his service details he was recruited under compassionate employment scheme vide order No. G.O.(Ms)34/88/Gl.Edn dated 2/2/1988. He was appointed vide Chief Engineer's Order No. EC5/96539/87 dated 22/2/1988. He is a PWD optee.

In the above circumstances, the name of the incumbent is hereby included in the common Seniority List of 3<sup>rd</sup> Grade overseers from 1/10/1981 to 31/3/1990 as rank No. 1357(A) in between Smt. Indira.K.V(1357) and Sri. Aboobacker.E(1358). His name is also included in the Final Seniority List of 3<sup>rd</sup> Grade Overseers as on 31/3/1990 as rank No. 581(a) in between Smt. Indira.K.V(581) and Sri.Balakrishnan.M.P (582).

Those who are aggrieved by this provisional inclusion of name may file their objection with relevant documents to prove their claim before the undersigned within one month from the date of issue of this order. If no objections are received within the specified time the ranks assigned to the incumbent will be finalized and confirmed.
